### EXPERIENCE IN WIDE-RANGING FIELDS OF LAW

Practicing in state, federal, and bankruptcy courts throughout the Rocky Mountain region, Britt has achieved outstanding results in cases involving myriad different fields of the law including:

#### **BREACH OF CONTRACT**

Britt has represented plaintiffs and defendants in hundreds of breach of contract cases. He was the prevailing party in a Colorado Supreme Court case that limited the reach of the implied covenant of good faith and fair dealing that exists in every contract.

#### **BUSINESS TORTS**

Many of Britt’s business cases have also involved tort claims such as fraud, embezzlement, defamation, abuse of process, tortious interference, and conspiracy. He successfully defended a multi-million dollar fraud case by persuading the plaintiff to voluntarily dismiss the case without any payment – a complete victory through negotiation that averted a costly trial.

#### **REAL ESTATE**

Britt has handled numerous real estate disputes involving purchase and sale transactions, development agreements, easements, encroachments, options, and title disputes among other matters. He was the prevailing party in a Colorado Supreme Court case establishing that a Colorado deed of trust encumbers unadjudicated non-tributary water lying below the encumbered land.

## **CREDITOR-DEBTOR RELATIONS**

Britt has handled innumerable collection actions, foreclosures, receiverships, and other proceedings to collect sums owed to lenders, including the defense of lender liability counterclaims. He has also represented lenders and borrowers in work-outs of troubled loans – achieving win-win agreements that enabled the borrowers to satisfy their obligations.

## **BANKRUPTCY**

Britt has assisted minority shareholders in obtaining redress for breaches of fiduciary duty by majority shareholders, and in achieving advantageous business “divorces” when partnerships are irretrievably broken.
