Howard Kenison is a former Colorado Deputy Attorney General and nationally recognized attorney in environmental law and litigation. He is a Past Chair of the American Bar Association (ABA) [Section of Environment Energy and Resources](#), an 8,000-plus member forum.

With over four decades of accomplishments, clients trust Howard to represent them in state and federal courts and administrative agency proceedings. He brings experience and practical knowledge assessing environmental risk and resolving legal issues for clients dealing with the complex array of environmental laws that can impact projects and commercial transactions. SUPERFUND LITIGATION

As Deputy Attorney General, Howard led a team of trial attorneys prosecuting seven major Superfund lawsuits in Colorado federal court.

- Litigation included the Rocky Mountain Arsenal Superfund Site — at the time one of the largest and most contaminated sites in the nation.

In private practice, he has argued Superfund issues before the U.S. Court of Appeals. Howard’s extensive

experience also includes cost recovery cases and natural resource damage matters.

- Representing a client in a case related to the de-listing of a Superfund landfill.
- Representing a steel mill client, a PRP at a major Superfund Site.
- Represented the City of Lakewood, Colorado, a PRP at the Lowry Landfill Superfund Site.
- Settled EPA Superfund claims against a client at an historic mining site in South Dakota.

ENVIRONMENTAL LIABILITIES AND DUE DILIGENCE

Howard regularly advises clients involved in complex asset, stock purchase transactions, real estate development projects and other business transactions concerning the allocation of environmental risks and liabilities, including environmental representations and warranties, indemnities and due diligence efforts. His experience litigating environmental cases provides a practical aspect to his advice.

- Howard has provided counsel to an electric generating utility concerning the potential environmental liabilities and the allocation of environmental risk arising from the acquisition, development and construction of a new generating facility.
- Provide advice and counsel regarding potential environmental liability for real estate development project to be developed on a closed landfill a on former federal facility.

CLEAN AIR ACT LITIGATION AND PERMITTING

Howard represents utility clients in litigation involving air permits and counsel's clients concerning permitting and compliance with state and federal clean air act laws.

- Howard represented a major electric utility concerning an air permit for a generating facility and was litigation counsel for this utility in lawsuits in appellate court related to the air permit.
- In the past he defended utilities involved in a visibility impact case brought under the federal Clean Air Act.

NEPA LITIGATION

Howard provides strategic advice and counsel to clients involved in preparing and, if needed, litigation of Environmental Impact Statements for utility transmission, highway transportation and water projects, including litigation-sensitive advice regarding comments for the administrative record involving purpose and need, environmental impacts, noise, air quality, wetlands, air toxics, traffic demand and Section 4(f) parks and historic properties.

- Howard represents the Jefferson Parkway Public Highway Authority as Special Environmental Counsel involving the completion of the transportation beltway around Metro Denver.
- He recently settled litigation involving a Colorado mutual ditch company that challenged the adequacy of an EIS involving a major trans-mountain diversion ditch.
- Howard has represented the E-470 Public Highway Authority and the Northwest Parkway Public Highway Authority as Special Environmental Counsel.

HAZARDOUS WASTE FACILITY LITIGATION AND PERMITTING

Howard successfully represented a county government before the Colorado Supreme Court regarding disposal of low-level radioactive wastes under the Rocky Mountain Low-Level Radioactive Waste Compact. He advised the client on all aspects of Colorado's Hazardous Waste Act and Colorado's radiation control provisions, including the state permitting process and applicable local land use laws.

WETLANDS PERMITTING AND ENFORCEMENT

Howard defends clients in federal wetland enforcement actions and represents developers and others seeking to obtain permits from the United States Army Corps of Engineers under Section 404 of the Clean Water Act.

- Howard has represented developers in EPA and Corps enforcement cases that involve disputes over the agencies' Clean Water Act jurisdiction, negotiations of the terms and conditions of Consent Decrees and Administrative Compliance Orders as well as the amount of civil penalties. Howard has also provided legal strategy concerning the development of alternatives analysis in complex 404 permit applications.

WATER QUALITY PERMITTING AND ENFORCEMENT

In addition to his wetlands practice, Howard provides advice and counsel to utility and other clients concerning NPDES permitting and represents clients where the government has initiated enforcement actions under state and federal water quality laws.

ENVIRONMENTAL AUDITS FOR CORPORATE RISK PREVENTION

To assist clients in avoiding government enforcement actions, Howard routinely advises clients undertaking environmental compliance and environmental management system audits. His counsel involves advice concerning the application of federal and state environmental audit and privilege laws designed to protect clients from environmental liabilities and penalties.

ENVIRONMENTAL INSURANCE LITIGATION

Howard served as environmental counsel for a large multi-state utility in a three-week jury trial seeking insurance recovery for releases of contaminants at three Superfund sites. The trial resulted in a \$7.1 million verdict for his client.
